Thank you for your purchase: We insist on the strength, design and manufacturing quality of all our products, and provide the following warranty.

What's covered

From the date of purchase, under normal use conditions and conditions, and in accordance with the recommendations of the user guide, within one year from the date of purchase, there are no defects in materials and workmanship.

During the warranty period, if the product fails, malfunctions or otherwise does not comply with the provisions of this "limited warranty", Napfox will repair or replace the frame or any part of the product free of charge (at the option of Napfox). All labor should be the responsibility of the owner.

The original proof of purchase is required to invoke this guarantee.

Uncovered content

This limited warranty does not cover normal wear and tear of the product.

If the product is incorrectly stored, assembled, altered and/or modified in any way, this warranty is invalid. Indications of improper assembly include broken/stripped loose pins and peeling threads on nuts/pedals.

It does not cover misuse/abuse or accident/damage, such as scratches, torn pillowcases or cosmetic damage to the desk paint/surface treatment.

As stated in the user guide, the product requires maintenance, and this warranty does not cover claims due to maintenance failure or improper maintenance, nor does it cover repairs to any noise caused by the following reasons: such as squeaking, hoarse, and Lack of preventive maintenance or thumping sound caused by lack of preventive maintenance.
